

Great North Run 2026 (Event) Terms and conditions (Terms)

- 1. You must be at least 17 years old on the date of the Event in order to take part.
- To secure a place (subject to availability) you must pay a £65.00 non-refundable registration fee (Registration Fee). You will be sent confirmation that your application has been successful.
- 3. By accepting these Terms and securing your place by payment of the Registration Fee, you pledge to raise a minimum of £200.00 (in addition to the Registration Fee) using an "Enthuse" online fundraising page and understand that it is the aim of this event to raise as much above this amount as possible for Northumbria Blood Bikes.
- 4. When you accept your place with the Great North Run, you will be guided through setting up your fundraising page on the Enthuse platform.
- 5. Monies claimed from HMRC under the Gift Aid scheme do not count towards your fundraising total.
- 6. If at any point you feel that you are unable to raise the pledged amount you should inform the challenge team at Team Blood Bikes immediately so that we can offer assistance with your fundraising.
- 7. All funds raised in the name of Northumbria Blood Bikes must be paid [within [30] days following the Event].
- 8. All additional costs related to the Event including, but not limited to, travel and accommodation are the participant's responsibility.
- 9. The place remains the property of Northumbria Blood Bikes. In exceptional circumstances we reserve the right to withdraw the place at any time.
- 10. Should you have to withdraw from the Event for any reason (including but not restricted to injury or illness) you must inform us immediately. When your withdrawal is acknowledged you will not be liable to raise any further sponsorship. Sponsorship funds already paid to are refundable (excluding the Registration Fee) and any sponsorship funds held by you at the date of withdrawal must be returned to the donors or donated to Northumbria Blood Bikes with the donors' permission.
- 11. Withdrawal from the Event will not be granted under any circumstances after the deadline for token redemption has passed (normally early July). If you are unable to run after this date, you will be required to pay the sponsorship pledge in full, or defer your place to next year's event.
- 12. Any deferred places must pay the Registration Fee again directly to event organisers 'the Great Run Company' to participate the following year. Tokens will then be distributed later the following year. Deferred places are those who are unable to partake in the Great North Run that year for whatever reason and choose to partake the following year.
- 13. All deferred places are still the property of Northumbria Blood Bikes and you will be required to raise the minimum sponsorship of £200.00 the following year.

- 14. We will not be liable for the safety and wellbeing of any participant and should you choose to participate in the Event you do so at your own risk. By accepting these Terms, you accept full and complete responsibility and liability for your own health and accept that it is your responsibility to achieve the standard of physical fitness reasonably required in order to cover the distance required by the Event.
- 15. It is your responsibility to consult your doctor if you have any concerns about your ability to complete the Event safely and to monitor your own physical condition during the Event.
- 16. You should ensure that you wear appropriate clothing and footwear for the Event particularly if the Event takes place in inclement weather.
- 17. You agree that Northumbria Blood Bikes can use any photograph(s) taken of you at the event in any literature, publicity, information material or publication promoting the charities work. This may include brochures, posters, leaflets, display boards, website and any other appropriate materials.
- 18. You agree that we will share your details with the Great Run Company for event logistic purposes.
- 19. You confirm your details can be used in accordance with the Northumbria Blood privacy policy.
